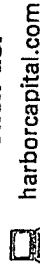

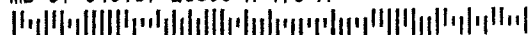

On May 2, 2022, Dodge & Cox Funds established additional share classes for six funds for eligible defined contribution retirement plans. With the creation of the new share class, we are renaming the current share classes of the six funds to Class I shares. If applicable, your fund holdings will reflect the updated name showing Class I.

Prevent your account(s) from being deemed "abandoned" by periodically maintaining contact with us. State unclaimed property laws require Dodge & Cox Funds to turn over an account's assets to the state it's registered under if one or more of the following occurs over a period of time (typically three to five years):

- You have an invalid mailing address on your account
- You have not maintained contact with us
- You have an uncashed check
