I. CALL TO ORDER

The meeting was called to order at 12:22 p.m.

II. AUDITOR REPORT

Mr. Murray distributed the Financial Statements for the Plan years ended June 30, 2023 and 2022, which are attached hereto as **Exhibit “A.”** He confirmed that the Financial Statements, in the opinion of Schultheis & Panettieri, LLP (“S&P”), present fairly, in all

material respects, the financial status of the Fund. Mr. Murray reviewed the Form 5500 in detail, including Schedule C, and reported that, without an extension, Form 5500 must be filed by January 31, 2024. He stated that the Fund's administrative expenses are reasonable and that the Plan continues to operate efficiently. He noted S&P's satisfaction with Associated Administrator's internal controls.

Mr. Murray reviewed the Form 990 in detail with the Trustees.

Mr. Murray was excused from the meeting.

III. INVESTMENT CONSULTANT REPORT

Mr. Patrick Blizzard distributed and reviewed the SEI report for the period ending December 31, 2023. He led a conversation regarding SEI's Outsourced Chief Investment Officer ("OCIO") model and SEI's services. He provided commentary on market conditions and economic trends, including inflation and Federal fund rates. He also discussed the market performance across different asset classes.

Mr. Blizzard reported that the Fund's market value of assets was \$6,645,393 as of December 31, 2023, and its fiscal year-to-date rate of return is 4.60%, compared to the 4.35% index return. Mr. Blizzard reviewed the Fund's asset allocation: 9.40% World Equity Ex-US Fund, 6.30% US Equity Factor Allocation Fund, 6.30% Large Cap Index Fund, 16.40% Core Fixed Income Fund, 40.10% Limited Duration Fund, 3.00% High Yield Bond Fund, 7.80% Real Return Fund, 3.10% Emerging Markets Debt Fund, and 7.60% Multi Asset Real Return Fund. He then reported on the performance of each asset class.

Mr. Blizzard said that SEI has no recommendations at this time.

IV. APPROVAL OF MINUTES

The minutes of the meeting held on October 20, 2023 were reviewed.

MOTION was made, seconded and unanimously adopted to approve the minutes of the meeting held on October 20, 2023.

V. ASSOCIATED ADMINISTRATORS, LLC REPORT

A. Cash Operating Statement

Ms. Cochran reviewed the Cash Operating Statement from July 1, 2023 through September 30, 2023. The report is attached hereto as **Exhibit "B."**

B. Claims Paid Detail Report

Ms. Cochran reviewed a report detailing medical claims paid by type of benefit from July 1, 2023 through September 30, 2023. The report showed paid claims by the following categories: anesthesia, COVID-19 testing, hospital, laboratory and x-ray, medical, surgery, and COVID-19 treatment. The report also indicated claims paid in network and out-of-network ("OON"). The report is attached hereto as **Exhibit "C."**

C. Disbursement Report

Ms. Cochran referred to the Authorization for Disbursements reports for July, August and September 2023. The reports are attached hereto as **Exhibit "D."**

MOTION was made, seconded and unanimously adopted authorizing the disbursements listed in Exhibit "D."

D. Delinquency Report

Ms. Cochran reviewed the report in detail. The report is attached hereto as Exhibit "E."

E. Withdrawal Liability

Ms. Cochran reviewed the report showing the status of withdrawal liability payments owed to the Pension Fund by the Welfare Fund in connection with the 2013 closing of the former Fund Office. The report is included at the bottom of Exhibit "E."

F. Employer Contribution Rate Report

Ms. Cochran reviewed the report in detail. The report is attached hereto as Exhibit "F."

G. Active Members and COBRA Participants Receiving Benefits

Ms. Cochran referred to the report for the period from January 2023 through December 2023. The report is attached hereto as Exhibit "G."

H. 2024 Summary of Benefits and Coverage ("SBC")

Ms. Cochran reported that the SBC for the period January 1, 2024 through December 31, 2024 was mailed to participants on November 22, 2023.

I. Notice of Privacy Practices Availability

Ms. Cochran reported that the Notice of Privacy Practices Availability was mailed to participants on November 22, 2023.

J. Subrogation Report

Ms. Cochran stated that, according to Anthem, there are no open cases.

K. Consolidated Appropriations Act (“CAA”) – Gag Clause

Ms. Cochran reported the CAA’s Gag Clause Attestation was successfully filed by Associated on behalf of the Fund.

VI. CONSULTANT’S REPORT

A. Amalgamated Disability Benefit Law (“DBL”) and Paid Family Leave (“PFL”) Policy Renewal

Ms. Davis reviewed Segal’s December 14, 2023 memorandum regarding the renewal. She stated that Amalgamated Life proposed maintaining the current rate for the Basic Life, Accidental Death and Dismemberment (AD&D), and Enhanced NY DBL (Disability Benefit Law) coverage effective January 1, 2024.

Ms. Davis reported that, based on the total participant count, the Basic Life estimated total annual premium is \$4,464, the AD&D annual premium is \$781, and the Enhanced NY DBL estimated annual premium is \$10,100. Ms. Davis noted that these rates have been guaranteed for two years through December 31, 2025.

Ms. Davis stated that the New York Department of Financial Services announced that the Paid Family Leave (PFL) rate per \$10 of weekly benefit will reduce from \$0.2943 in 2023 to \$0.2412 in 2024, which is an approximate 18% reduction; that the maximum annual premium contribution per participant will decrease by 16.6% from \$399.43 in 2023 to \$333.25 in 2024; and that the maximum weekly benefit will increase from \$1,131.09 to \$1,151.16, or by 1.8%. She advised that the annual cost of the NY PFL policy will be \$41,323 based on a rate of \$333.25 per participant for 124 participants, which amounts to a maximum decrease of \$66.18 per participant annually. She stated that, based on 124 participants, the annual premium reduction will total \$8,206.

Following discussion,

MOTION was made, seconded and unanimously adopted to approve the above-described Amalgamated policy renewals effective January 1, 2024.

B. Financial Experience and Budget Projections Report

Mr. Urbank reviewed the Financial Experience and Budget Projections Report for the fiscal year ended June 30, 2024. He commented that the report is based on two years of audited data through 2022 and unaudited cash flows provided by Associated for the year ended June 30, 2023. He explained that the three years of projected income and expenses begin July 1, 2024. Mr. Urbank reported that, for fiscal year 2023, total expenses of \$2,430,153 exceeded total income of \$2,153,028, thereby resulting in an operating deficit of \$277,125. He stated that, after adjusting for the unrealized gain on investments of \$8,366, the Fund experienced a total addition to net assets of \$268,759. He noted that, as of June 30, 2023, net assets, excluding Incurred but Not Reported ("IBNR") claims reserves, totaled \$6,393,902, for a reserve of 28.1 months down from 32.9 months in the prior year.

Mr. Urbank stated that, with regard to the projections, employer contributions are based on 40 hours worked per week and known contribution rates over the three years, resulting in average weekly contribution rates of \$317.60, \$323.62 and \$324.60 for fiscal years ending June 30, 2024, 2025 and 2026, respectively. He stated that total income is projected to fall short of the projected total expenses each year, resulting in projected operating deficits of \$435,900, \$611,600 and \$838,700 in the years ended June 2024, 2025 and 2026, with net assets declining to \$5,958,002 as of June 30, 2024, for a reserve of 24.5 months if the projections reach fruition.

Mr. Urbank reviewed the different contribution rates for the employers, noting that if the four employers with the lowest rates contributed at the average composite higher rate of the remaining employers, the Fund would realize additional income of \$325,000 in fiscal year 2024.

Discussion ensued regarding the logistics of increasing contribution rates, especially that of Precast Concrete which is contributing under an expired Collective Bargaining Agreement (“CBA”) with the Union. After discussion, it was agreed that Ms. O’Leary will draft a letter regarding the expired CBA and the need for a higher contribution rate to Precast and the Union for the Trustees’ review and approval.

C. Fidelity Bond Coverage

Mr. Urbank reviewed a memorandum summarizing Fidelity Bond Insurance Coverage proposals from the incumbent Chubb, as well as from Zurich and Encore/Hudson. Ms. Cochran stated that the Pension Fund Trustees previously voted in favor of Chubb. The Trustees agreed to approve coverage from Chubb. She noted that the premium will be allocated between the Pension and Welfare Funds.

MOTION was made, seconded and unanimously adopted to approve the Chubb Fidelity Bond Policy.

VII. COUNSEL

A. Draft Amended and Restated Agreement and Declaration of Trust

Ms. O’Leary distributed binders with the current Trust Agreement and Amendments and a draft updated Trust Agreement. She explained that the draft incorporates all Amendments adopted to date. She reviewed the other proposed changes in the Trust Agreement, including, but not limited to, (1) removal of certain references to the Union and Contributing Employers; (2) updating the document to reflect that the Fund

has retained a third-party administrator; (3) broadening the deadlock arbitration provisions; (4) updating provisions regarding procedures for Trustees' decisions; (5) adding the power to merge as a specific power of the Trustees; (6) specifying the Trustees' powers with respect to contributions and the issuance of rules applicable to Employers; (7) deletion of the requirement that the Fund provide short-term disability benefits; and (8) adding in a provision specifying that, except as otherwise provided, all actions taken by Trustees shall be considered fiduciary actions. The Trustees and counsel discussed the impact of the proposed updates. It was agreed that a final draft will be adopted at an upcoming meeting.

VIII. NEXT MEETING DATE/ADJOURNMENT

It was agreed that the next regular meeting of the Board of Trustees was scheduled for April 19, 2024 immediately following the Pension Fund meeting via WebEx. With no further business to come before the Board, the meeting was adjourned at 1:30 p.m.

Independent Auditor's Report

Board of Trustees
Industry and Local 338 Welfare Fund

Opinion

We have audited the accompanying financial statements of the Industry and Local 338 Welfare Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of June 30, 2023 and 2022, and the related statements of changes in net assets available for benefits and plan benefit obligations for the years ended June 30, 2023 and 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial status of the Plan as of June 30, 2023 and 2022, and the changes in financial status for the years ended June 30, 2023 and 2022 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental information on pages 15 through 16 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental information on pages 17 through 18 is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JUNE 30, 2023 AND 2022

Note 1 - Description of Plan and Significant Accounting Policies

The following description of the Industry and Local 338 Welfare Fund (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan first became effective June 26, 1950 and is a welfare benefit plan established under an Agreement and Declaration of Trust pursuant to collective bargaining agreements between Teamsters Local 445 (the "Union") and various employers in the State of New York. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Management has evaluated subsequent events through the date of the auditor's report, the date the financial statements were available to be issued.

Purpose

The purpose of the Plan is to provide health and other benefits to eligible participants.

Benefits

Benefits are paid by means of a self insured trust and group insurance contracts. The benefits include, but are not limited to, life insurance, accidental death and dismemberment, weekly disability, hospital, surgical, medical, major medical, dental, optical and prescription drug benefits for eligible participants.

Actual benefits, including conditions and limitations thereto, are governed by the provisions of the Plan.

Participants consist of the following classes

Active participants and dependents

Plan coverage is available to participants who are in a collective bargaining unit represented by the Union and who work for employers who contribute to the Plan.

Coverage for benefits, other than weekly disability, generally begins on the first day of the month after completion of 30 consecutive days of covered employment. However, if the collective bargaining agreement between the employer and the Union have different eligibility rules, those rules apply.

Eligibility for the Plan's weekly disability benefit begins as soon as the participant starts working for a contributing employer.

Note 1 - Description of Plan and Significant Accounting Policies (cont'd)

Participants consist of the following classes (cont'd)

Inactive participants and surviving dependents

Participants who fail to meet eligibility requirements may pay to extend coverage for a maximum period of 18 months. Qualifying spouses and dependents may pay to extend coverage for a maximum period of up to 36 months.

Plan termination

The Trustees expect and intend to continue the Plan indefinitely, but reserve the right to amend or terminate it as provided for by the applicable Trust Agreement and Plan provisions. If the Plan is terminated, trust assets will be used to pay all expenses under the terms of the Plan in the order of priority specified in the Plan and as otherwise required by law.

Basis of accounting

The financial statements are presented on the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investments are stated at fair value. See "Fair value measurements" footnote for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Other Plan benefits

Estimated claims payable, claims incurred but not reported, and premiums due to insurers are based on payments made in the subsequent plan year which pertain to prior plan years.

Plan obligations for accumulated eligibility of active participants are estimated annually at June 30th, based on historical claims cost data and projected claims for active participants' future claims. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value. Although the Plan has calculated and reported an obligation for accumulated eligibility, this amount is based on the assumption that the Plan will continue in its current form and that the Trustees will continue to provide benefits to active participants. However, such benefits do not vest, and the Trustees reserve the right to amend the Plan to modify or discontinue benefits. The amount reported as the accumulated eligibility obligation represents the estimated present value of those estimated future benefits that are attributed by the terms of the Plan to active participants' service rendered through June 30th.

Note 2 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices, in active markets, for identical assets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include: quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 inputs are generally based on the best information available, which may include the reporting entity's own assumptions and data.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies: Valued at the closing price reported in the active market in which the securities are traded.

Note 2 - Fair value measurements (cont'd)

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 3 - Cash

At times throughout the year the Plan may have, on deposit in banks, amounts in excess of FDIC insurance limits. The Plan has not experienced any losses in such accounts and the Trustees believe it is not exposed to any significant credit risks.

Note 4 - Party-in-interest transactions

Certain Plan investments are held by the manager of the investment; therefore, transactions relating to those investments qualify as exempt party-in-interest transactions and are identified as such on the supplemental schedules of investments.

Note 5 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Note 6 - Employers' contributions

In accordance with collective bargaining agreements, employers are required to make contributions to the Plan on behalf of employees performing covered work. For the years ended June 30, 2023 and 2022, three employers contributed approximately 85% and 91% of the total contributions, respectively.

Note 7 - Stop loss recoveries

In an effort to limit its exposure for self insured benefits, the Plan has a stop-loss insurance policy with HCC Life Insurance Company, effective April 1, 2023. The stop-loss policy was previously BCS Insurance company. For the year ended June 30, 2023 and 2022, the Plan incurred stop-loss recoveries in the amount of \$143,216 and \$335,461 respectively, which have been netted against benefits paid.

We have audited the financial statements of Industry and Local 338 Welfare Fund (the "Plan") for the year ended June 30, 2023, and have issued our report thereon. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you for the current year. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Findings

Qualitative Aspects of the Organization's Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are disclosed in the notes to the financial statements. No new significant accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most significant estimate affecting the financial statements is as follows:

Management's estimate of the incurred but not reported and accumulated eligibility benefit obligations are based on claims payment history and the probability of payment.

We evaluated the key factors and assumptions used to develop the estimates identified above and determined that the amounts used are reasonable in relation to the financial statements taken as a whole.

Significant Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The following material misstatements detected as a result of our audit procedures were corrected by management:

Adjustment to record stop loss receivable - \$143,216

Misstatements detected as a result of audit procedures do not include journal entries based on information provided by management, since they were recorded by us merely as a convenience to us or management.

Management has corrected all misstatements identified during the audit.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated as of the date of the audit opinion letter.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Supplemental Schedules Required Under the DOL's Rules and Regulations for Reporting and Disclosure Under ERISA

With respect to the supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

Other Supplemental Schedules

With respect to other supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with accounting principles generally accepted in the United States of America, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.
