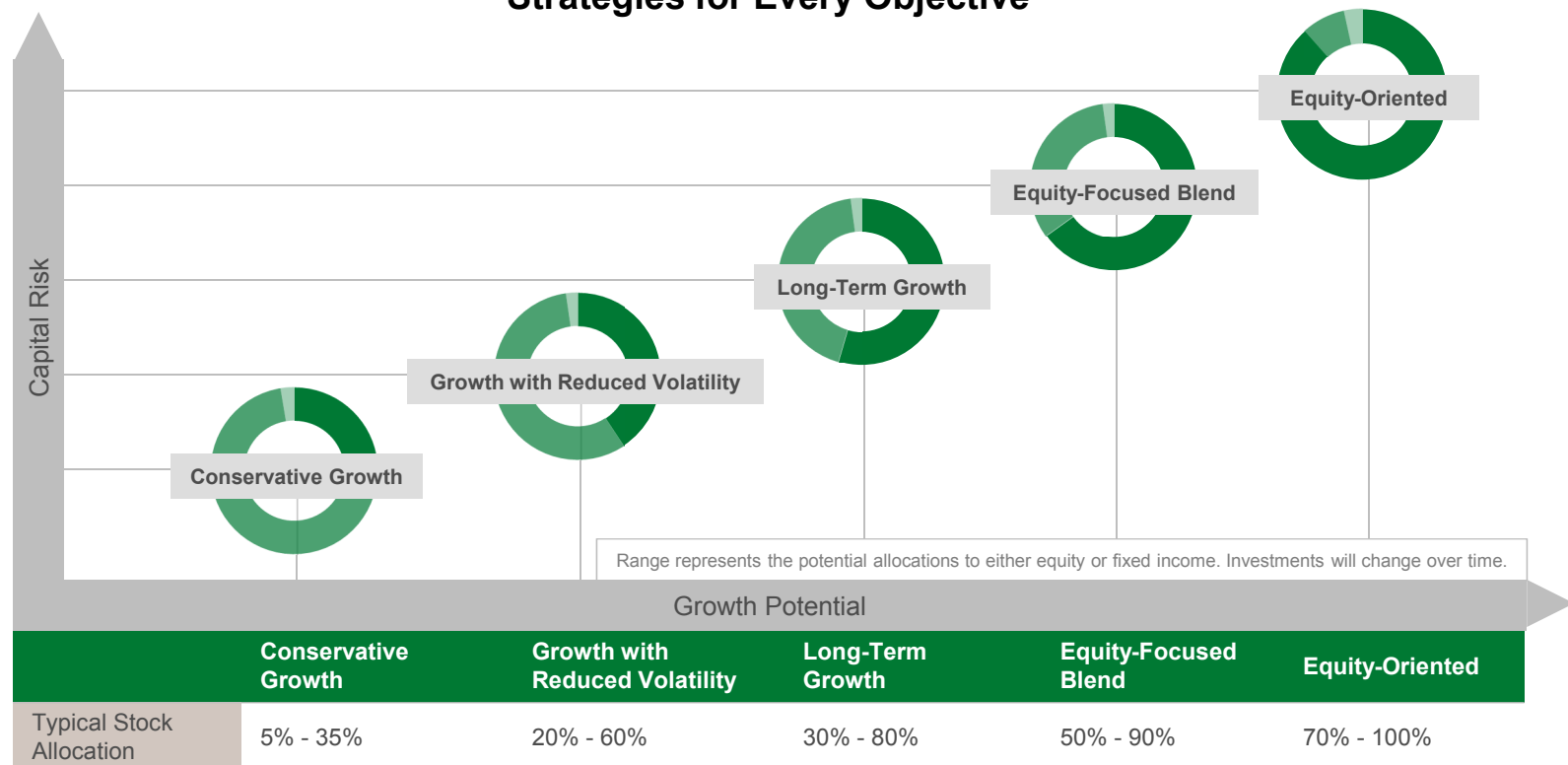

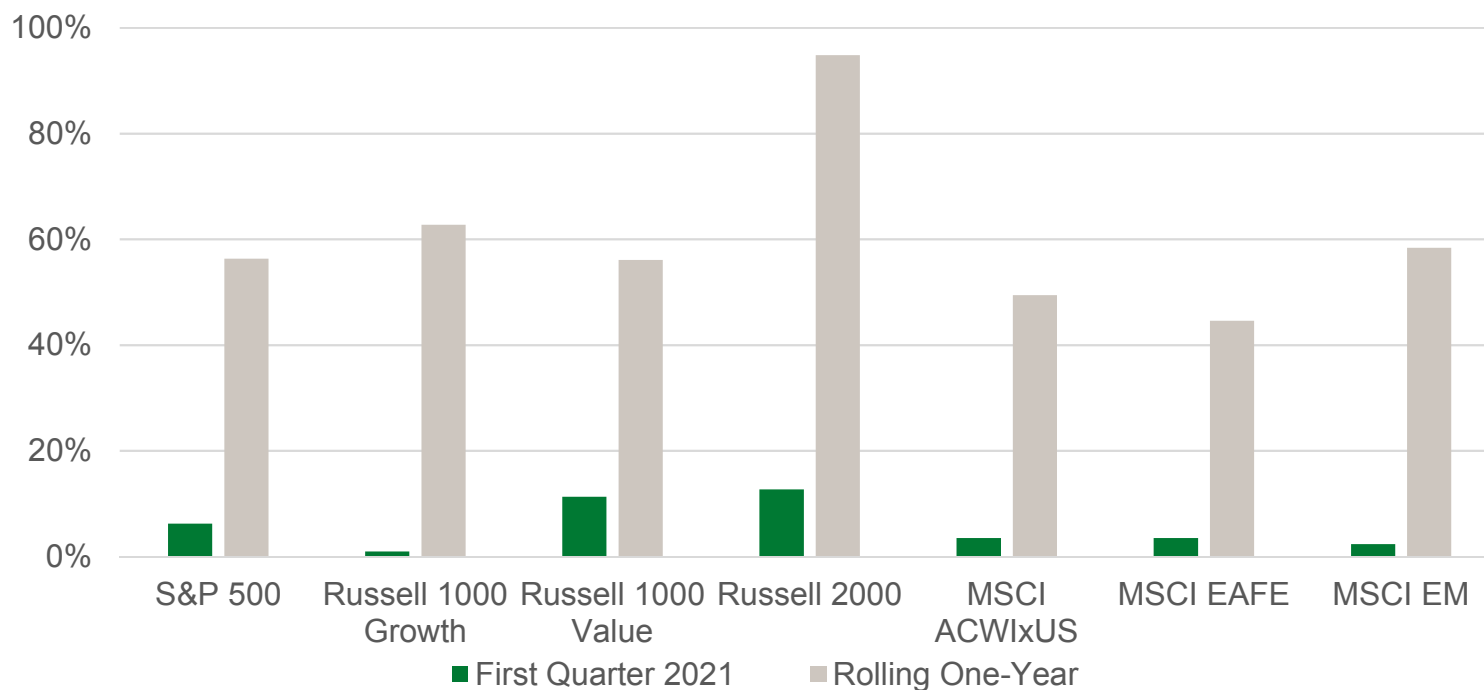

An Exceptionally Strong Post-Pandemic Rally



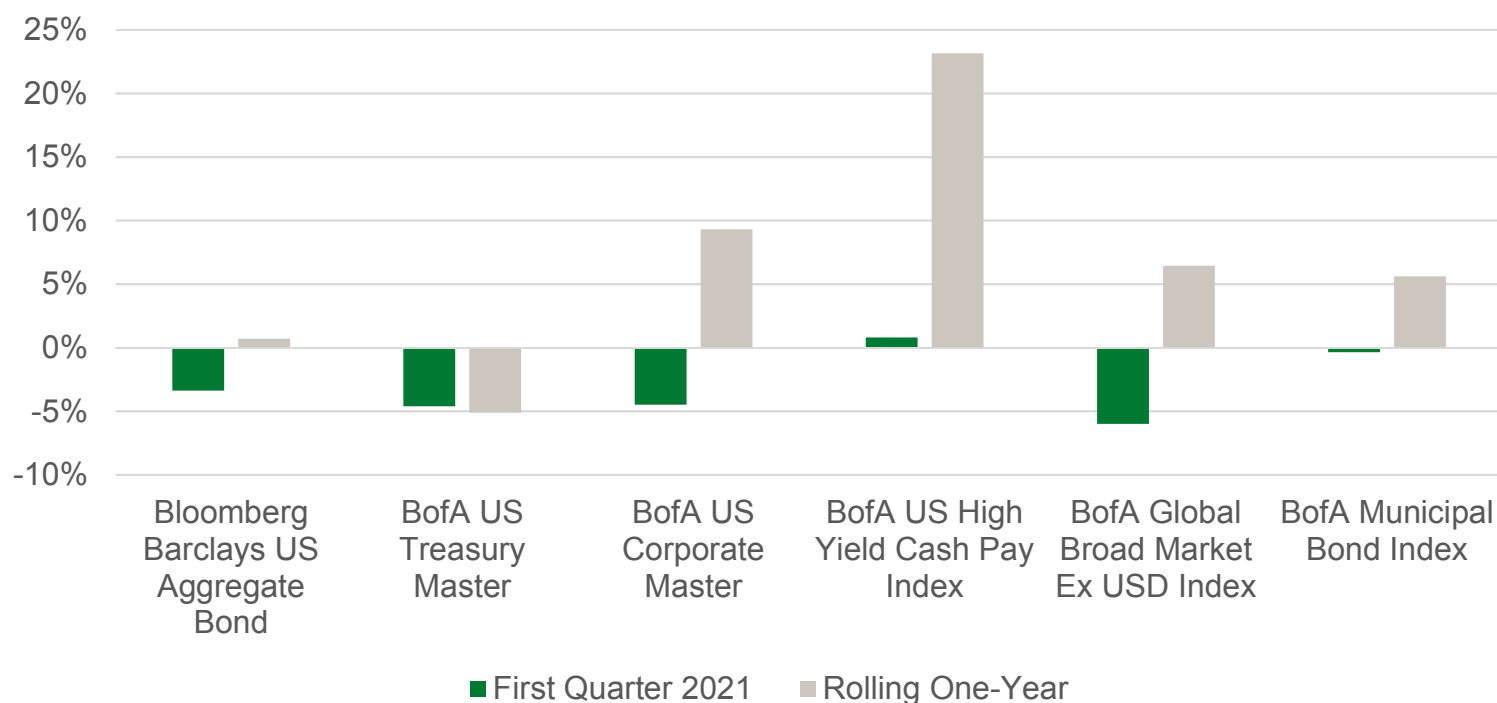

Rates Jump on Economic Optimism



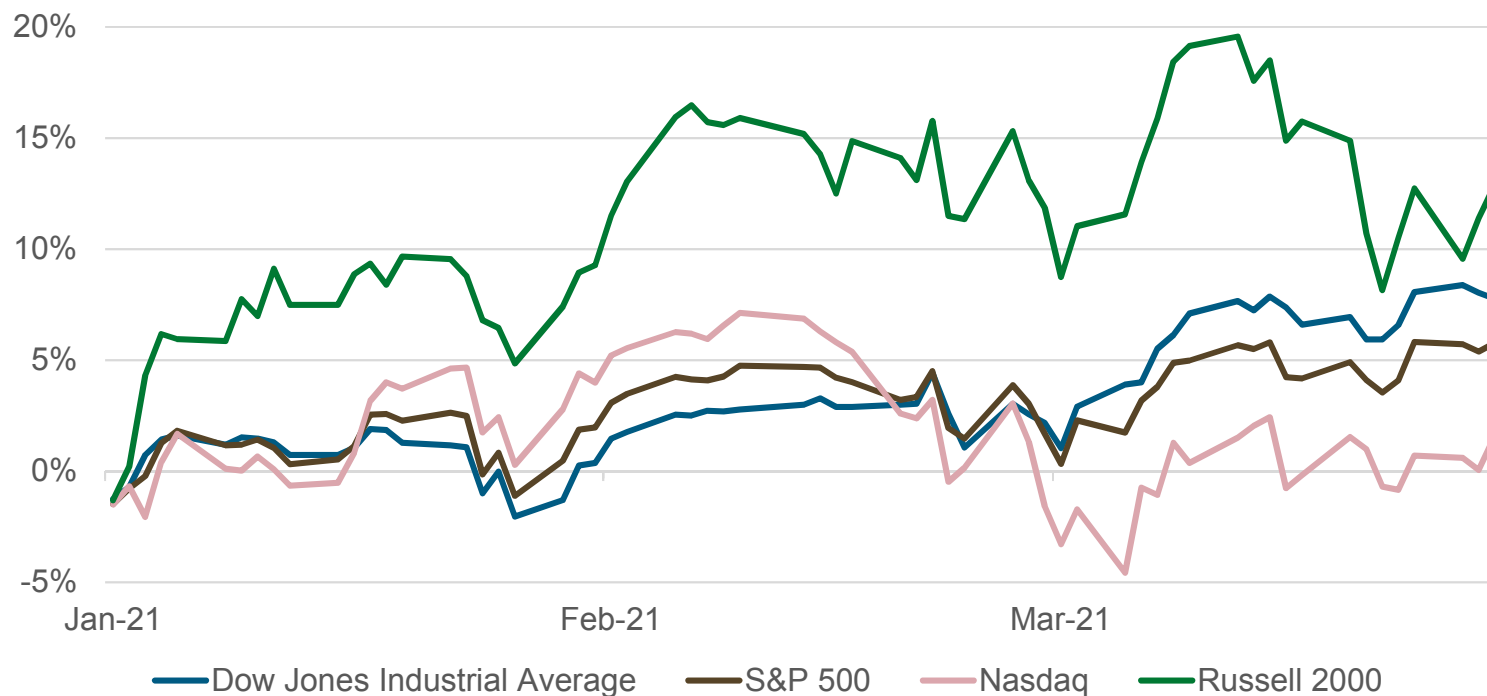

Equity Markets were Choppy but Higher



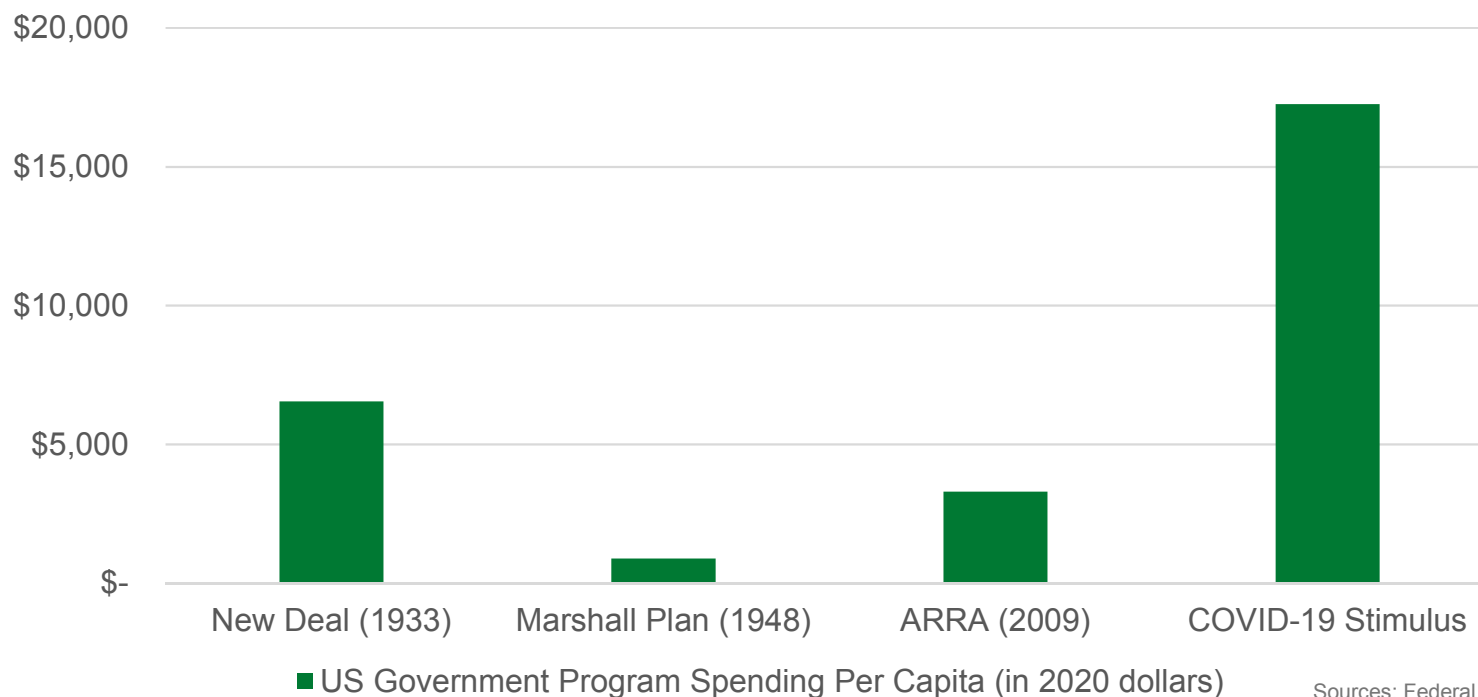

US Treasury Yields Jump, Challenging Returns



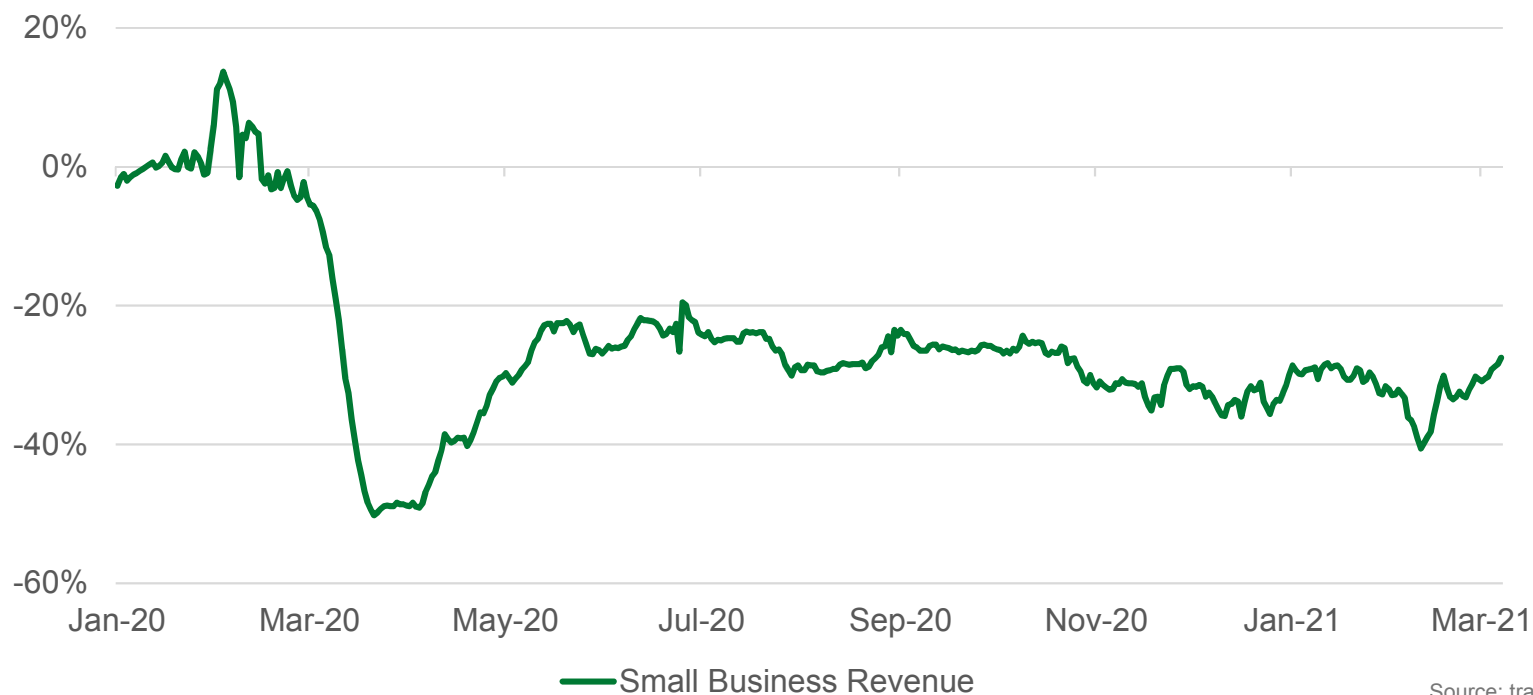

- Certain sectors of the economy (e.g., leisure and hospitality), certain segments of the population (e.g., lower income workers), and certain types of businesses (e.g., small businesses) remain deeply devastated by the pandemic

Key Takeaways:

- Despite certain weaknesses, rising economic growth projections are generating higher corporate earnings expectations, providing some support for the recent market gains
- Even with improving fundamentals, valuations remain elevated in both equity and fixed income markets
- As a result, and due to exuberant investor sentiment, we believe a degree of judiciousness remains appropriate

Current Equity Positioning

Our view on the economy is positive, but overly enthusiastic investor sentiment and elevated valuations partially temper our market outlook

We expect to remain flexible and opportunistic, focusing on risk and reward

Key areas we like today include economically sensitive businesses in a variety of industries, as well as select growth opportunities where valuations remain appropriate. For example:

- We see value in economically-sensitive areas, such as in the energy and materials sectors (e.g., natural gas producers and construction aggregates)
- Our teams believe in the long-term prospects of several growth-oriented industries (e.g., cloud computing, gaming, payment processing, and digital advertising)
- We are selectively adding what we believe are best-in-class companies in a variety of industries (e.g., biotechnology and pharmaceuticals)

Current Fixed Income Positioning

Although rates have risen for longer-dated US Treasury securities, tight credit spreads across much of the bond market continues to create a challenging yield environment for fixed income investors

Given today's low-rate backdrop, we are:

- Selectively capturing opportunities in lower rated investment grade corporate bonds (e.g., within communications, energy, and financial services issuers)
- Finding value within certain segments of the asset-backed and commercial mortgage-backed credit markets (e.g., student loans, prime autos, single family rentals, agency multifamily CMBS)

For taxable clients:

- Municipal credit spreads are near historic lows, and in general, the sector has become less attractive on a relative basis
- Where we do find opportunities are in revenue bonds and select higher quality general obligation bonds

OBJECTIVE SUMMARY

Long-Term Growth Objective

To provide long-term growth, for the purpose of meeting future needs. A secondary objective is to preserve capital and dampen year-to-year volatility.

CURRENT POSITIONING - STRATEGY OVERVIEW

The economic growth outlook improved sharply this quarter. There was notable progress in the distribution of COVID-19 vaccine across the U.S., the substantial American Rescue Plan stimulus package was passed, and the monetary backdrop remained highly supportive. Broad equity markets hit all-time highs, albeit in a choppy fashion, as optimism about the economic re-opening was occasionally offset by concerns over rising interest rates. U.S. equity markets generally outperformed those overseas, and within domestic equity markets there were notable divergences. The more cyclical areas of the market, which tend to be categorized as value, handily beat their growth counterparts for the second quarter in a row. Likewise, smaller capitalization stocks outpaced the larger spectrum of the market. This was one of the most challenging quarters for fixed income markets in decades as rising inflation and growth prospects led to a historic jump in interest rates over such a short period. Losses were experienced in most sectors, though longer-dated securities were hit hardest as the yield curve steepened.

In the second half of 2020, we increased exposure to economically sensitive areas of the market that we expected to benefit from an economic reopening and recovery. This year, as the market broadly rewarded those types of stocks, we've trimmed back on some of these types of holdings as they've reached our fair value. For example, we modestly decreased our energy holdings related to the oil hurdle rate following recent strength in the sector. While conditions continue to track well, and we still maintain a sizeable overweight, we felt it was prudent to trim positions in certain companies that were more highly levered to oil prices after such a strong run. Specifically, we sold out of Schlumberger and decreased allocations to Pioneer Resources and ConocoPhillips, each of which are either exploration & production or oilfield services companies. Likewise, we sold out of our positions in Compass Group, the largest foodservice company in the world, and Hilton Hotels as they've benefitted from the economic reopening and no longer offer as attractive risk/reward profiles.

In terms of additions to the strategy, we reinvested back into several attractively priced secular growth companies that have been largely ignored by investors thus far this year. For example, we increased exposure to several companies tied to various secular digital trends, such as Amazon, Facebook, and Microsoft due to increasingly attractive risk/reward tradeoffs. In addition, we re-initiated a position in Seagen and increased allocations to BioMarin Pharmaceutical and Vertex Pharmaceuticals, all part of our biotech basket, as we think there is significant upside potential due to the breadth and depth of their pipelines. We had previously trimmed our biotech exposure back in 2019 ahead of the election cycle, which culminated in a moderate Democratic win. While there may be some attempts at legislation, we do not believe there will be a material negative impact to the biopharma industry or to our holdings, which we believe are particularly well-insulated from political risk due to their commitment to meaningful R&D and generally responsible pricing practices.

With respect to fixed income, the market in general continues to look expensive from a valuation perspective; however, we continue to find select opportunities across various sectors. Specifically, we are

finding attractive opportunities in the corporate credit space, particularly within the Communications, Energy, and Financials sectors, and, despite tightening valuations, in select BBB-rated issuances from a bottom-up perspective. Additionally, we continue to view commercial mortgage backed securities (CMBS) and asset-backed securities as relatively attractive and are focusing on securities with seniority in the capital structure that are backed by asset classes with high-quality fundamentals and low credit risk (e.g., student loans, prime autos, single family rentals, agency multifamily CMBS, etc.).

For taxable accounts, municipal yields marginally rose during the quarter in comparison to taxable bonds, resulting in slightly negative returns. In general, municipal bonds have become less attractive on a relative basis as municipal/Treasury ratios have become more compressed. Within the municipal market, we continue to have a positive view of revenue bonds, and within general obligations (GOs), we have a relatively higher quality tilt due to our selectivity within the sector.

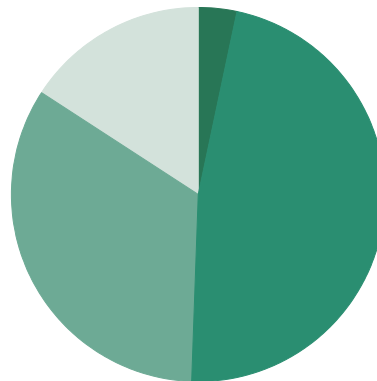

Agency Bond: A bond issued by a government agency. These bonds are not fully guaranteed in the same way as U.S. Treasury and municipal bonds.

Annualized Return: Returns for periods longer than one year are expressed as "annualized returns," equivalent to the compounded rate of return. Bond Rating: A grade given to bonds that indicates their credit quality. Effective Duration: The average time it takes to collect a bond's interest and principal repayment. Long-Term Fixed Income represents securities with maturities greater than ten years.

Market Capitalization: The market value of a company's outstanding shares. This figure is found by taking the stock price and multiplying it by the total number of shares outstanding. Small capitalization stocks have a market capitalization less than \$5.0 billion. Mid capitalization stocks have a market capitalization of greater than \$5.0 to less than \$20 billion. Large capitalization stocks have a market capitalization of greater than \$20 billion.

DESCRIPTION OF TERMS & METHODOLOGY - CONTINUED

Market Cycle - A period of history encompassing a full range of stock market conditions such as one market peak to the next, or one market bottom (often called a trough) to the next. By showing both positive and negative periods, a market cycle provides a representative time frame for measuring investment performance.

Net Asset Value (NAV) The total value of the assets, including stocks, bonds, and/or other securities, owned by a mutual fund, less all liabilities, divided by the number of outstanding shares. This value does not include any sales charges, such as a load or 12b-1 fee. The NAV is calculated once each day after the close of the market.

Par Value: Face value of a bond.

Preferred Stocks: A class of ownership in a corporation that has a higher claim on the assets and earnings than common stock. Preferred stock generally has a dividend that must be paid out before dividends to common stockholders and the shares usually do not have voting rights. The precise details as to the structure of preferred stock is specific to each corporation. Preferred Stock will be classified as fixed income within the report.

Pre-Refunded Bond (Pre-Refund): A type of bond issued to fund another callable bond, where the issuer actually decides to exercise its right to buy its bonds back before the scheduled maturity date. The proceeds from the issue of the lower yield and/or longer maturing pre-refunding bond will usually be invested in Treasury bills (T-bills) until the scheduled call date of the original bond issue occurs.

Revenue Bond: A municipal bond supported by the revenue from a specific project, such as a toll bridge, highway, or local stadium.

Standard Deviation: A gauge of risk that measures total volatility, or the spread of the difference of returns from their average. The more a portfolio's returns vary from the average, the higher the standard deviation.

Time-Weighted Return: The investment performance of a unit of assets held continuously for the entire time period measured. This rate provides an effective standard for comparing the performance of different portfolios, in which cash flow could vary considerably. The

money manager usually cannot control the timing or the amount of contributions to or withdrawals from a portfolio. Because the time-weighted rate reduces the impact of money flows, it is an appropriate means of appraising the portfolio manager's ability to make the assets of the portfolio perform.

US Treasury (Treasury): A marketable, fixed-interest U.S. government debt security.

Turnover Ratio: The turnover ratio measures the percentage of holdings that have been "turned over", or replaced with other holdings during the reflected time period. The lesser of the cost of purchases or proceeds from sales is divided by the average market value for the period and annualized if appropriate for the given period.

Yield to Maturity: The yield earned on a bond from the time it is acquired until the maturity date. The calculation of YTM takes into account the current market price, par value, coupon interest rate and time to maturity.
