Below please find an overview of benchmark changes that are being applied to several of our investment strategies. These changes would only be applicable to your account(s) if they are invested in the following strategies:

Disciplined Value Unrestricted Primary Benchmark

Please note that the strategy's primary benchmark has changed from the Russell 1000 Value Index to a blended benchmark comprised of 80% Russell 1000 Value Index and 20% S&P ADR Index. The Russell 1000 Value Index will continue to be provided for reference as a secondary benchmark going forward. This change is being made to provide you with a performance comparison against a primary benchmark that includes American Depositary Receipts ("ADRs") and ordinary shares of non-U.S. companies traded on a U.S. exchange (i.e., the S&P 500 ADR Index). ADRs are defined broadly as certificates issued by U.S. banks that represent shares of a non-U.S. company. Both ADRs and non-U.S. stocks traded on U.S. exchanges have been included as part of the strategy's universe of securities since its inception. As such, we believe this blended benchmark more closely aligns with the portfolio's investable opportunity set.

Growth with Reduced Volatility, Withdrawal from Total Return, and Manning & Napier Moderate Term Series Primary Benchmarks

Please note that the fixed income portion of the strategy's primary benchmark has changed from the Bloomberg Barclays US Aggregate Index to a combination of the Bloomberg Barclays US Aggregate and Bloomberg Barclays US Intermediate Aggregate Indices. This change is being made to more closely align with the portfolio's expected and historical portfolio characteristics, including sector positioning.

This change does not indicate a change in strategy or a reversal from our traditional active approach. Manning & Napier continues to use benchmarks as performance comparison tools; they do not drive our investment process.

Multi-Asset Class Secondary Benchmark

Please note that we are adding a secondary benchmark to multi-asset class portfolios in an effort to provide taxable accounts with greater context regarding the fixed income component of their benchmarks. Specifically, a large portion of a taxable account's fixed income exposure is obtained via investments in municipal bonds, which are not included in the portfolio's primary benchmark. By including both benchmarks, we believe we are able to provide taxable clients with a more relevant point of reference for evaluating performance.

This change does not indicate a change in strategy or a reversal from our traditional active approach. Manning & Napier continues to use benchmarks as performance comparison tools; they do not drive our investment process.

First Quarter 2020

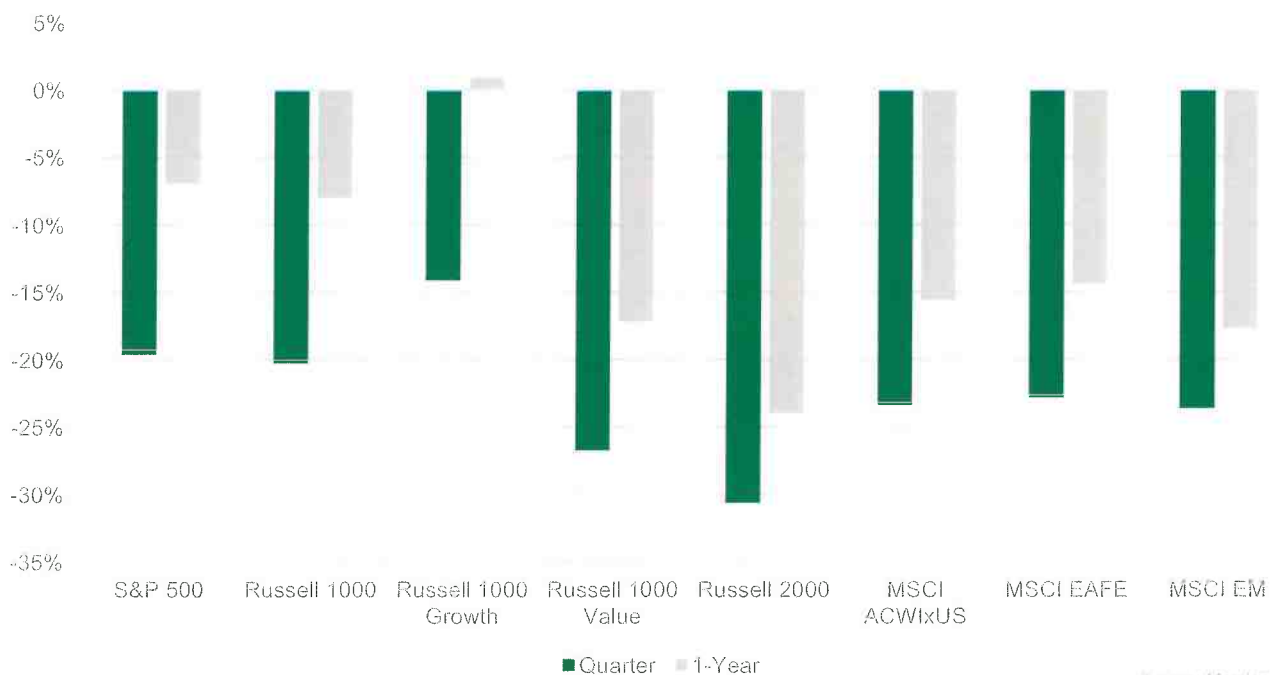

Equity Market Performance (as of 03/31/2020)

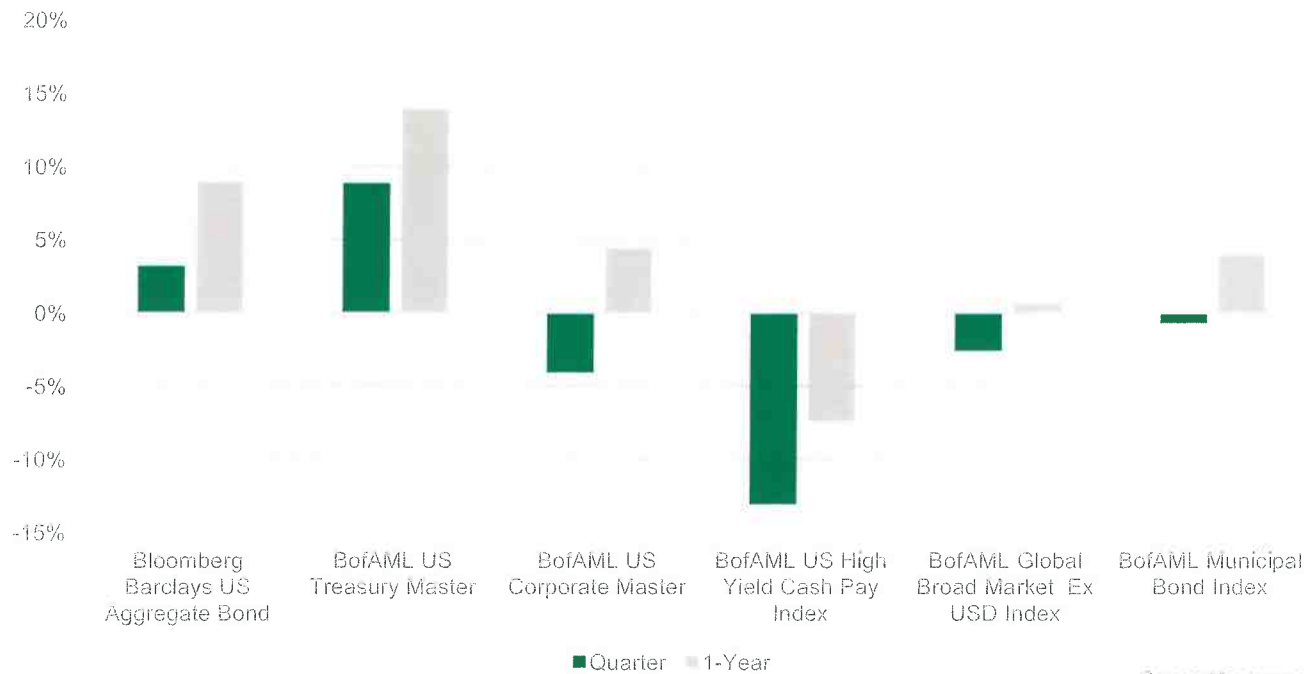

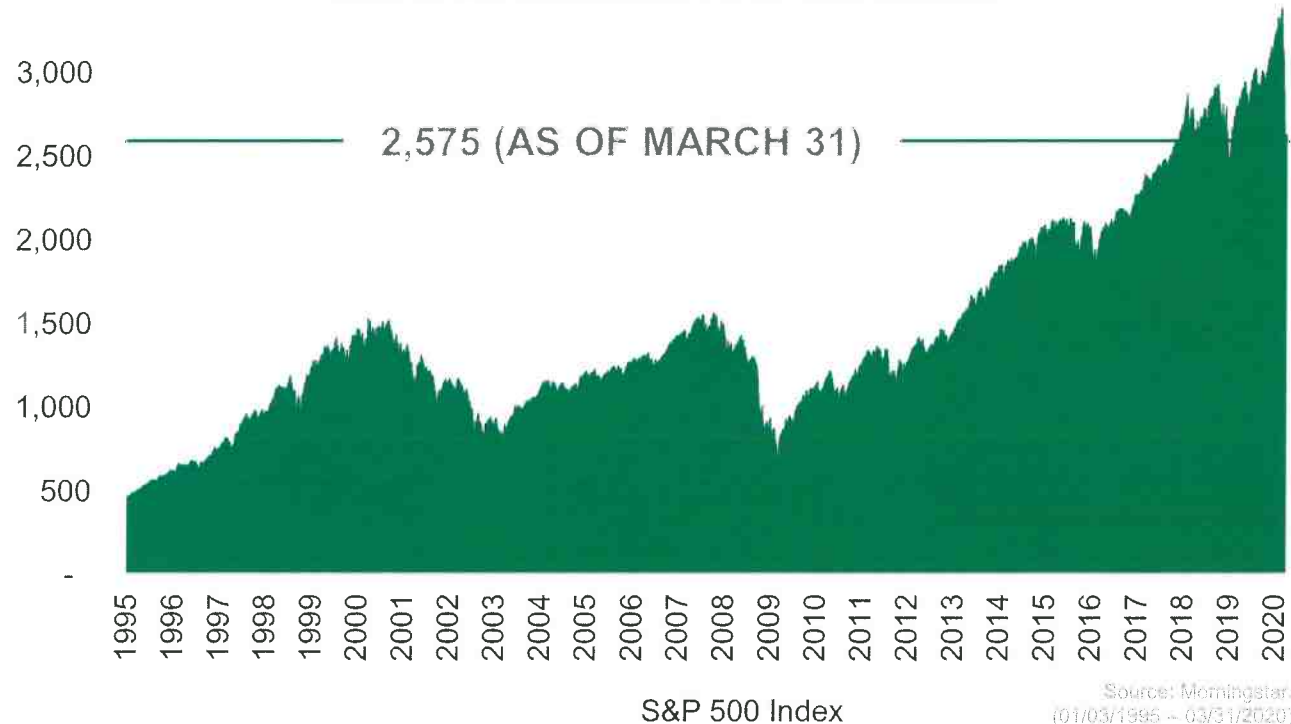
Fixed Income Market Performance (as of 03/31/2020)

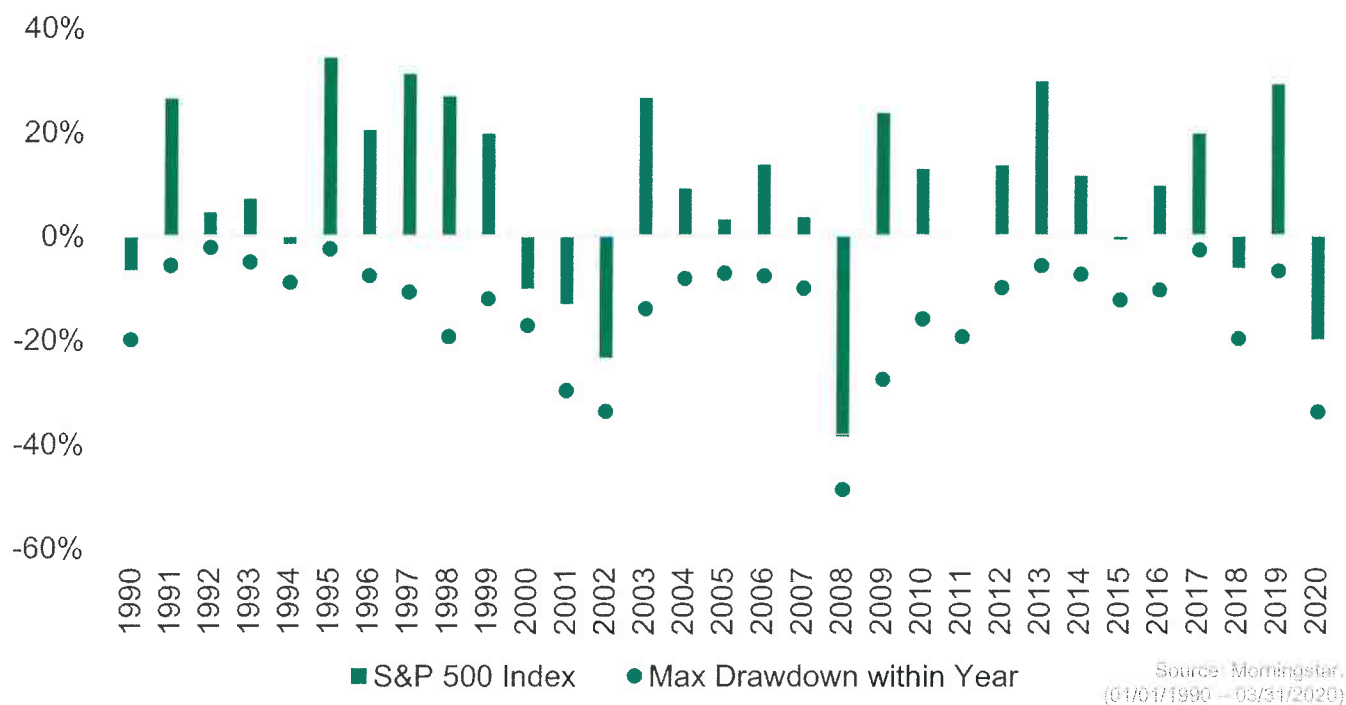
End of Historic Bull Run

Markets Sell Off in Up and Down Years

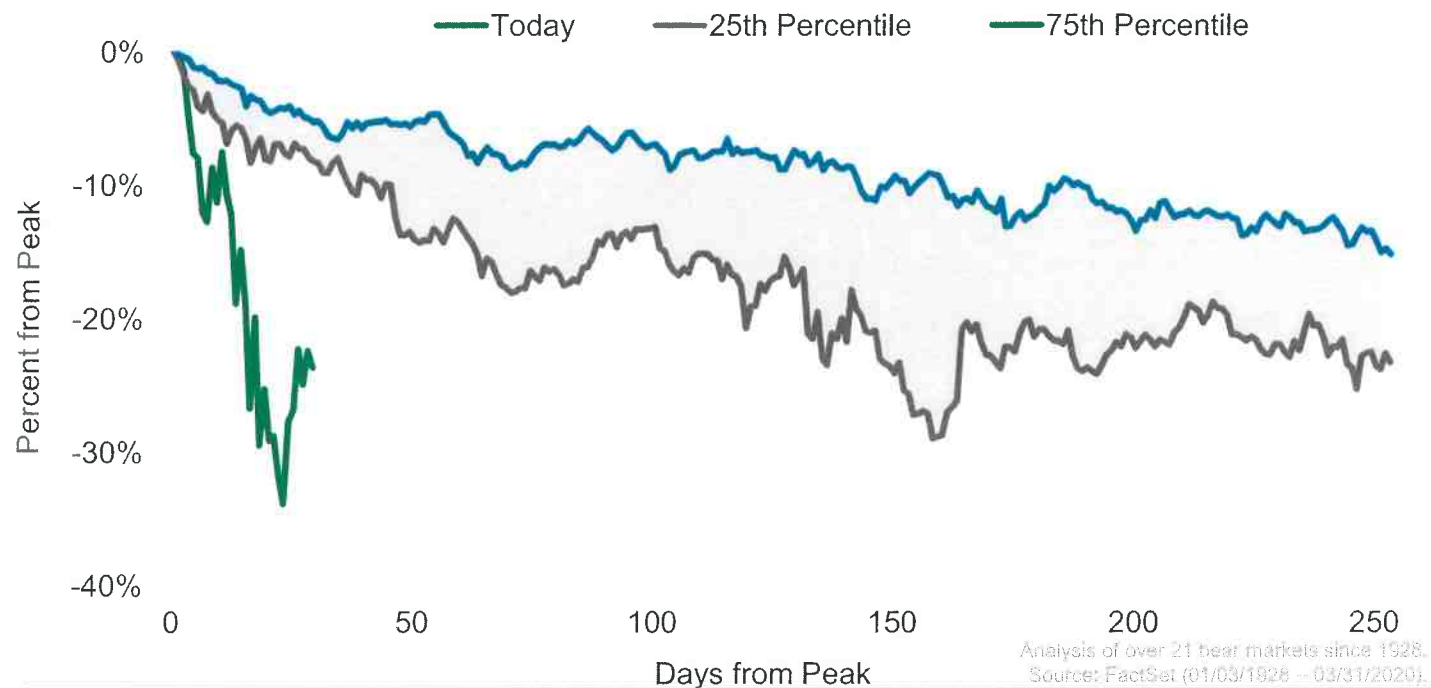

Remarkable in its Speed

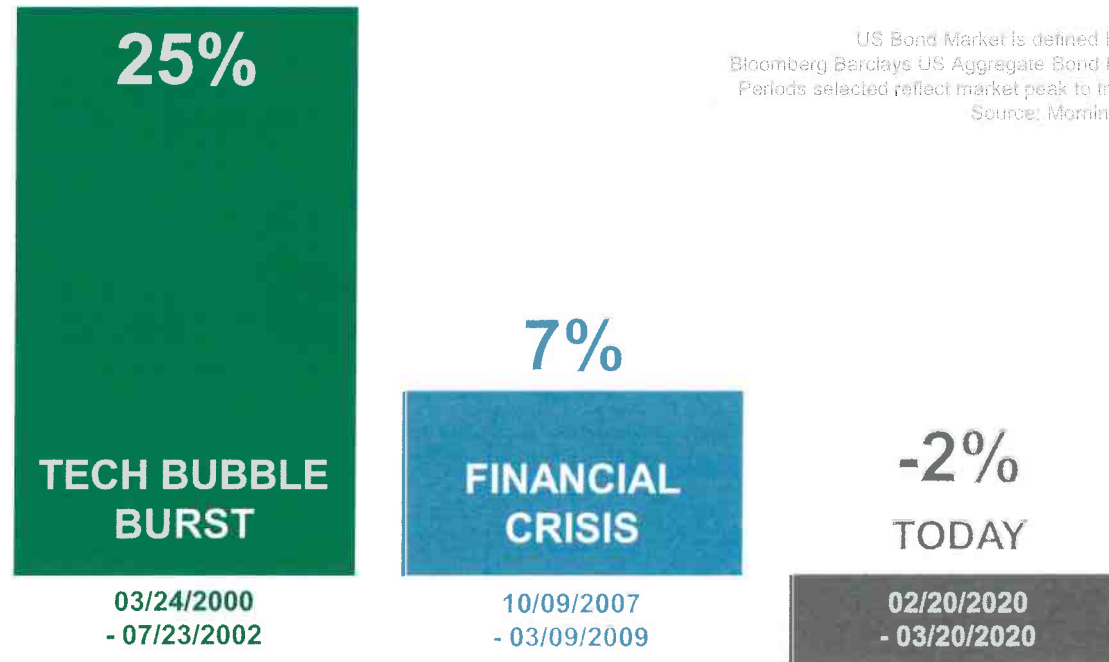
TODAY VS THE PAST 90 YEARS OF BEAR MARKETS

Fixed Income Provides Little Return



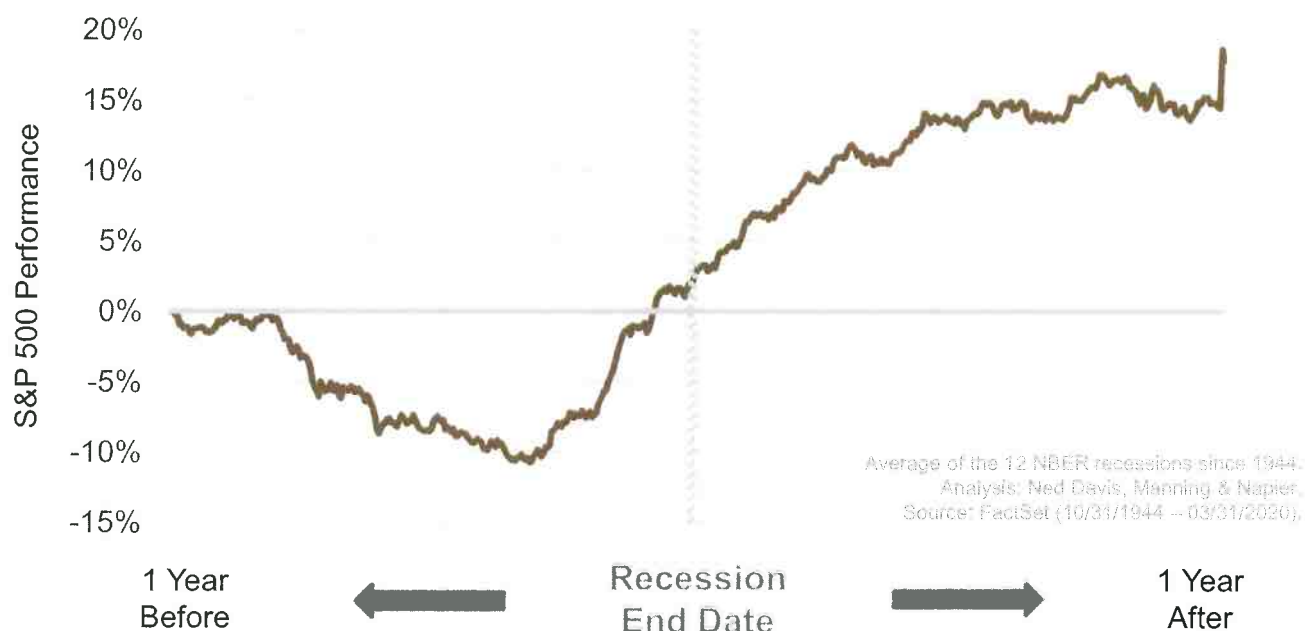
CUMULATIVE RETURNS OF THE US BOND MARKET

Stocks Turn Around Before the Economy

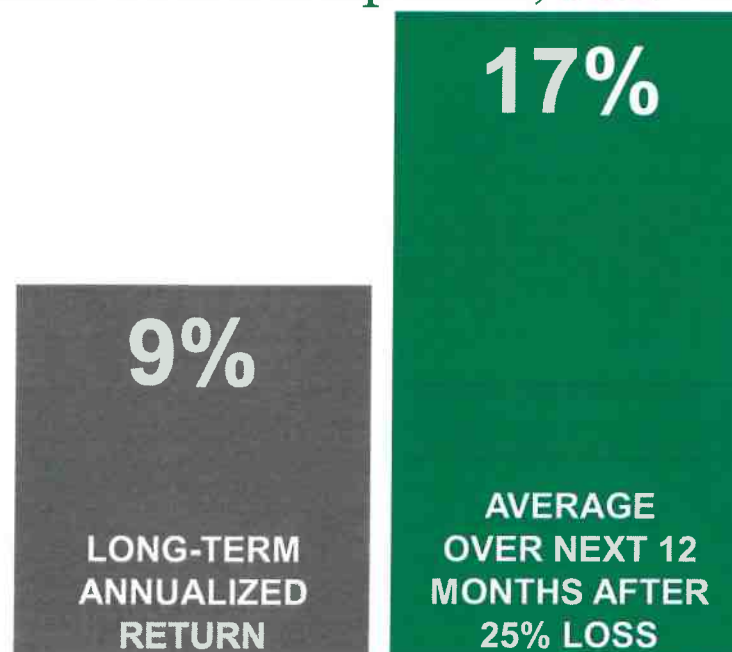
(AVERAGE OF THE PAST 12 RECESSIONS SINCE 1944)

OBJECTIVE SUMMARY

Long-Term Growth Objective

To provide long-term growth, for the purpose of meeting future needs. A secondary objective is to preserve capital and dampen year-to-year volatility.

CURRENT POSITIONING - STRATEGY OVERVIEW

Global equity markets experienced significant volatility during the first quarter, driven by the COVID-19 pandemic and resulting economic uncertainty. In response, fiscal and monetary measures were taken across the globe. From a historical perspective, while drawdowns of 20% or more are not unprecedented, the speed at which U.S. equity markets declined was the fastest on record. Looking forward, when stocks experienced similar deep declines in the past, the market has often gone on to earn above average returns over the following year.

Within the U.S., large-cap equities significantly outperformed small-cap equities and growth outperformed value. While no sector posted a gain this quarter, the more cyclical areas—Materials, Industrials, Financials, and Energy—were notable laggards. Looking outside the U.S., international equity markets experienced slightly greater losses, with developed markets slightly outperforming emerging markets. Within fixed income, Treasury yields declined to all-time lows as investors flocked to “safety” while corporate bonds experienced steep losses as both investment grade and high yield spreads widened significantly.

We entered the year cautiously positioned as the economy exhibited later cycle characteristics, such as low unemployment rates and strong consumer confidence levels, and equity markets were broadly expensive relative to their underlying fundamentals. As a result of this positioning, the portfolio performed strongly on a relative basis, outperforming its blended benchmark during the quarter.

The quick and dramatic market selloff during the quarter provided us with the opportunity to increase equity exposure as certain areas became more attractively priced. We primarily focused on upgrading toward high-quality businesses that are positioned for strong future growth, provide significant value to customers, and trade at attractive valuations.

Manning & Napier’s Strategic Profile strategy—one-of-three proprietary equity selection strategies that have been in place since the firm’s inception—seeks to identify these industry leaders. Some of these businesses, such as Alphabet, Amazon, and Facebook were already in our portfolio, and we chose to increase our allocations to them; others were new additions. For example, the Walt Disney Company was purchased when its stock price was down significantly in March. Despite near term challenges associated with its theme park closures, the stock was purchased with an eye towards its longer-term value. In addition, Salesforce, an industry-leading provider of customer relationship management software and other complementary cloud-based solutions, was added to the portfolio this quarter. We previously owned Salesforce and welcomed the opportunity to repurchase the stock after it sold off this quarter.

We also selectively added several energy-related positions under our Hurdle Rate strategy this quarter. We initiated positions in several integrated oil and gas companies, exploration and production

companies, and natural gas producers. We anticipate these segments of the energy market will benefit as the supply/demand balance in the industry improves. In a related move, we began existing our position in Halliburton as we think oil field services companies will be negatively impacted by the decline in oil prices.

Regarding fixed income positioning, we believe a somewhat shorter duration is in clients' best interests as yields have fallen notably across the curve. On a sector basis, valuations for U.S. Treasuries have become less attractive given the significant decline in yields. Additionally, despite recent volatility in mortgage-backed securities, recent Fed intervention has caused the sector to stabilize, making valuations less attractive. As such, we are finding more compelling opportunities elsewhere in fixed income markets. Specifically, both investment grade and high yield credit spreads have moved to recessionary levels, making valuations extremely attractive. Additionally, we are seeing select opportunities in short to intermediate term asset-backed and ~~commercial-mortgage-backed~~ securities.

For tax-sensitive clients with exposure to municipal bonds, we are actively allocating between municipal bonds and taxable securities to find the best value. Within municipal bonds, we continue to have a generally positive view of revenue bonds, with a focus on higher quality/essential service bonds.

The portfolio experienced a higher than average level of trading activity this quarter. This is not unusual. We increased trading activity during the last two bear markets as compelling investment opportunities tend to increase during periods of extreme volatility. We continue to monitor the environment and remain opportunistic to actively position client portfolios in what we believe to be the best long-term values.

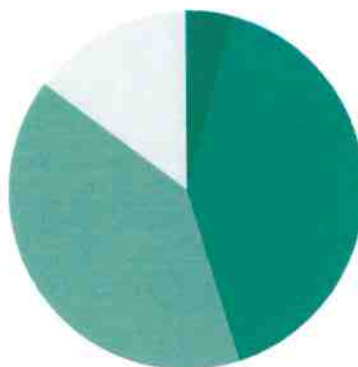

Agency Bond: A bond issued by a government agency. These bonds are not fully guaranteed in the same way as U.S. Treasury and municipal bonds.

Annualized Return: Returns for periods longer than one year are expressed as "annualized returns," equivalent to the compounded rate of return. This is the annual increase in value of an investment, including compounding of interest and dividends; as well as price appreciation that is expressed as a percentage of the starting price.

Bond Rating: A grade given to bonds that indicates their credit quality. Private independent rating services such as Standard & Poor's, Moody's and Fitch provide these evaluations of a bond issuer's financial strength, or its ability to pay a bond's principal and interest in a timely fashion. Bond ratings may be expressed as letters ranging from 'AAA', which is the highest investment grade, to 'C' ("Junk"), which is the lowest grade. Different rating services use the same letter grades, but use various combinations of upper and lower case letters and numbers to differentiate themselves.

AAA and AA: High credit-quality investment grade

A and BBB: Medium credit-quality investment grade

Convexity: A measure of the rate of change in the relationship between bond prices and bond yields that demonstrates how the duration of a bond changes as the interest rate changes. Convexity is used as a risk-management tool, and helps to measure and manage the amount of market risk to which a portfolio of bonds is exposed.

Effective Duration: The average time it takes to collect a bond's interest and principal repayment. It is a measure of the sensitivity of the price (the value of principal) of a fixed-income investment to a change in interest rates. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Duration is expressed as a number of years.

Emerging Markets: Emerging market countries are defined utilizing the MSCI Emerging Markets IndexSM.

Estimated Annual Income: Based upon the assets held as of the end-date of the review, an estimate of income from dividends and interest which may be received over the next twelve months. Market Capitalization: The market value of a company's outstanding shares. This figure is found by taking the stock price and multiplying it by the total number of shares outstanding. DESCRIPTION OF TERMS & METHODOLOGY - CONTINUED

Market Cycle - A period of history encompassing a full range of stock market conditions such as one market peak to the next, or one market bottom (often called a trough) to the next. By showing both positive and negative periods, a market cycle provides a representative time frame for measuring investment performance.

Net Asset Value (NAV) The total value of the assets, including stocks, bonds, and/or other securities, owned by a mutual fund, less all liabilities, divided by the number of outstanding shares. This value does not include any sales charges, such as a load or 12b-1 fee. The NAV is calculated once each day after the close of the market.

Par Value: Face value of a bond.

Preferred Stocks: A class of ownership in a corporation that has a higher claim on the assets and earnings than common stock. Preferred stock generally has a dividend that must be paid out before dividends to common stockholders and the shares usually do not have voting rights. The precise details as to the structure of preferred stock is specific to each corporation. Preferred Stock will be classified as fixed income within the report.

Pre-Refunded Bond (Pre-Refund): A type of bond issued to fund another callable bond, where the issuer actually decides to exercise its right to buy its bonds back before the scheduled maturity date. The proceeds from the issue of the lower yield and/or longer maturing pre-refunding bond will usually be invested in Treasury bills (T-bills) until the scheduled call date of the original bond issue occurs.

Revenue Bond: A municipal bond supported by the revenue from a specific project, such as a toll bridge, highway, or local stadium.

Standard Deviation: A gauge of risk that measures total volatility, or the spread of the difference of returns from their average. The more a portfolio's returns vary from the average, the higher the standard deviation.

Time-Weighted Return: The investment performance of a unit of assets held continuously for the entire time period measured. This rate provides an effective standard for comparing the performance of different portfolios, in which cash flow could vary considerably. The

money manager usually cannot control the timing or the amount of contributions to or withdrawals from a portfolio. Because the time-weighted rate reduces the impact of money flows, it is an appropriate means of appraising the portfolio manager's ability to make the assets of the portfolio perform.

US Treasury (Treasury): A marketable, fixed-interest U.S. government debt security.

Turnover Ratio: The turnover ratio measures the percentage of holdings that have been "turned over", or replaced with other holdings during the reflected time period. The lesser of the cost of purchases or proceeds from sales is divided by the average market value for the period and annualized if appropriate for the given period.

Yield to Maturity: The yield earned on a bond from the time it is acquired until the maturity date. The calculation of YTM takes into account the current market price, par value, coupon interest rate and time to maturity.
