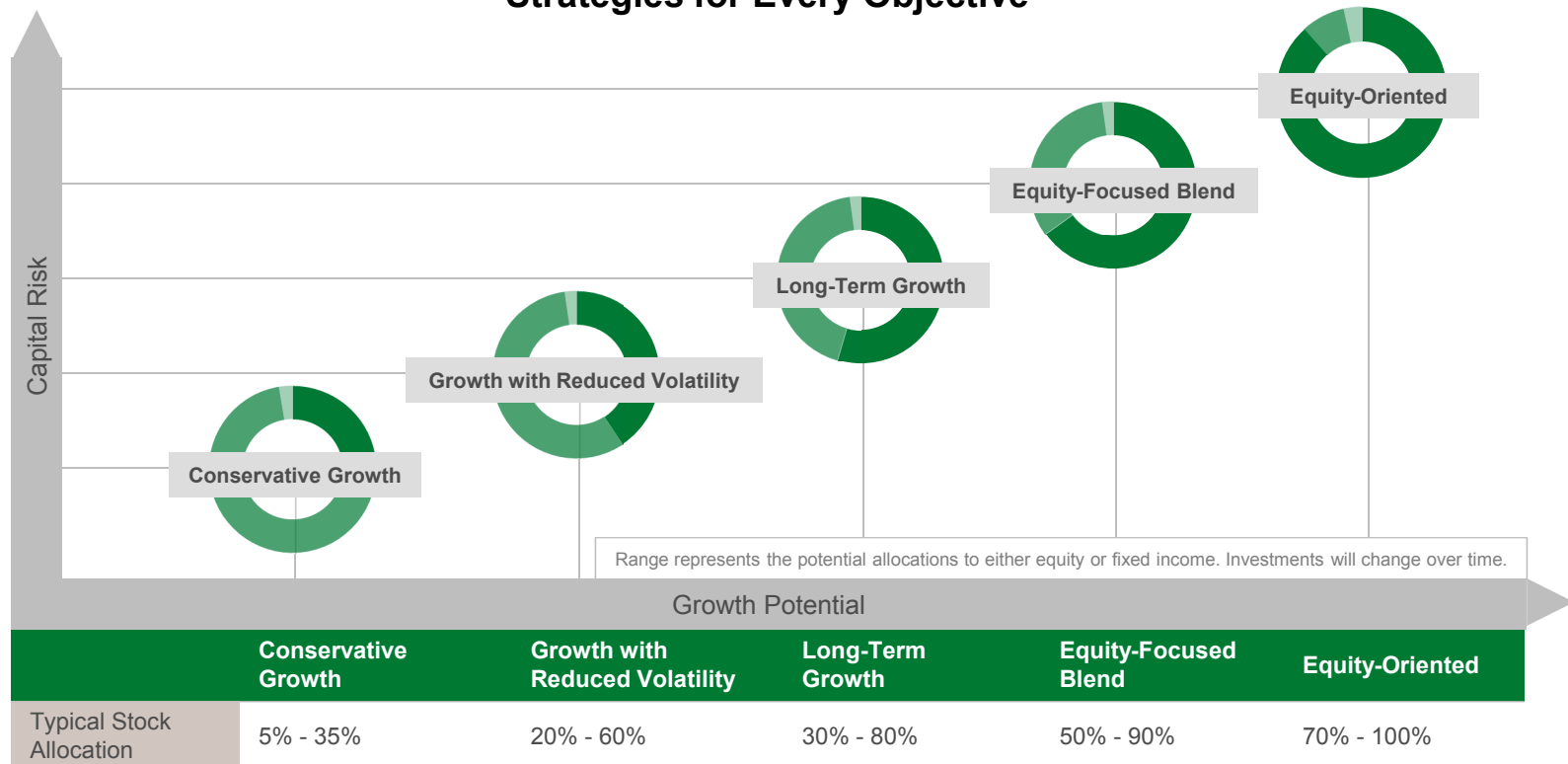

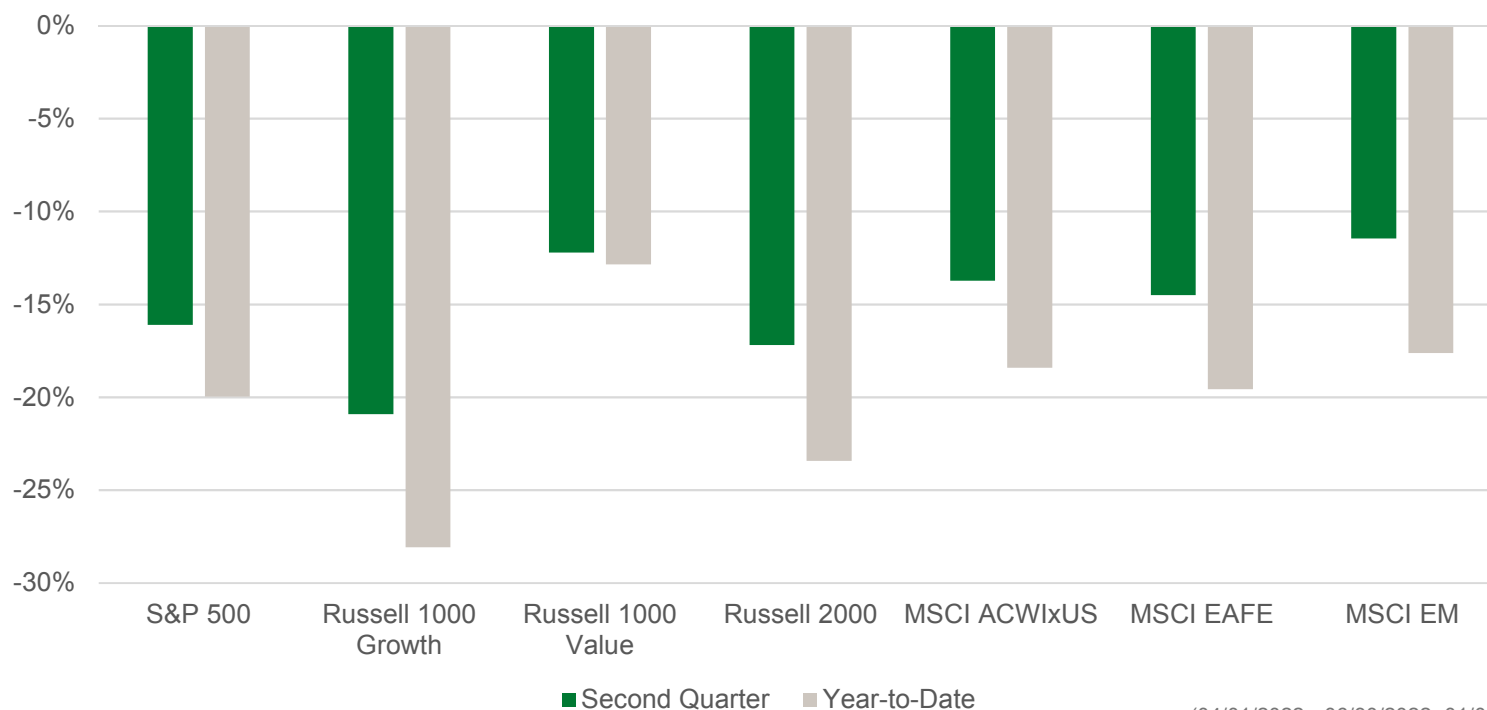

US Equities Fall Into A Bear Market

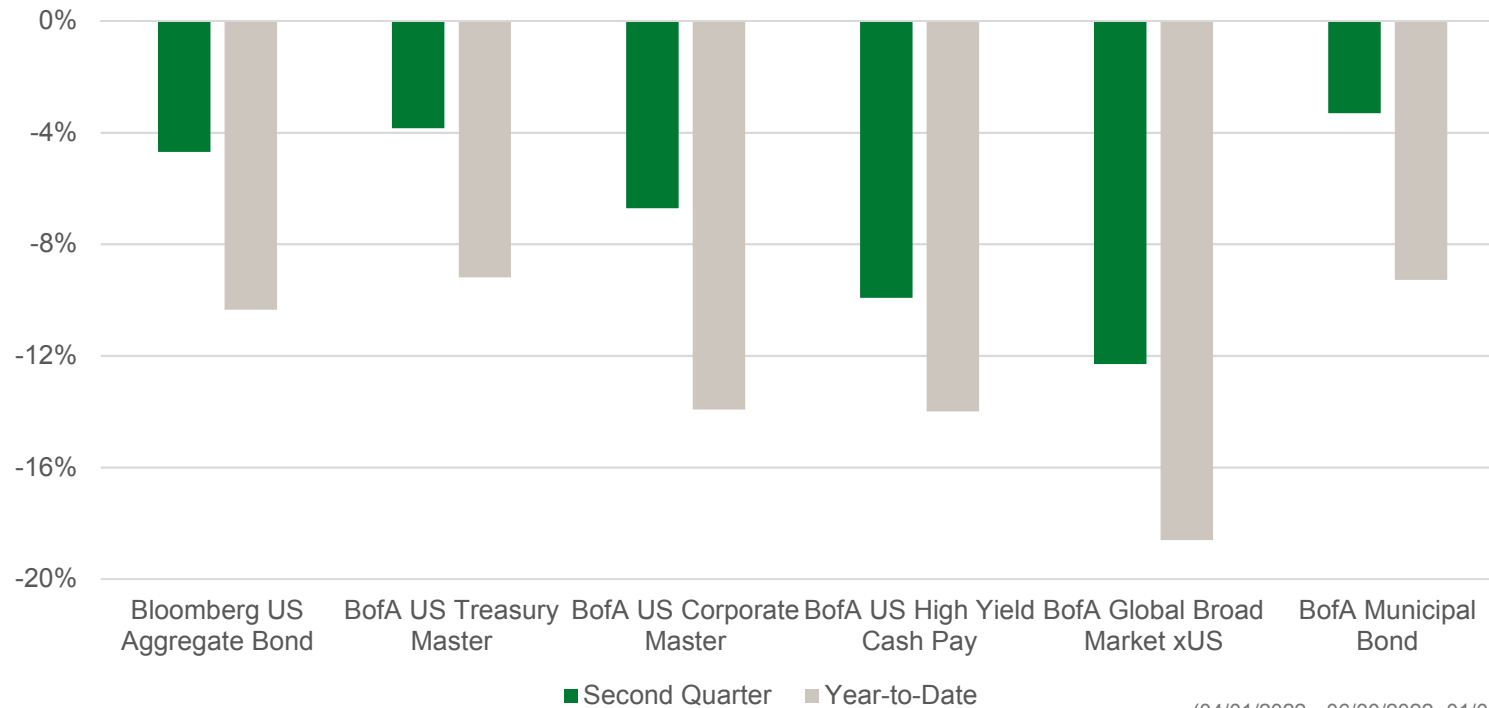

- The start of 2022 has been a historically difficult one for US equity markets, as well as internationally
- Within equities, growth-style stocks have taken a step back, underperforming the value-style both for the quarter and year, as investors exited names considered higher risk in the event of an economic slowdown
- Smaller capitalization stocks remain substantial underperformers year-to-date

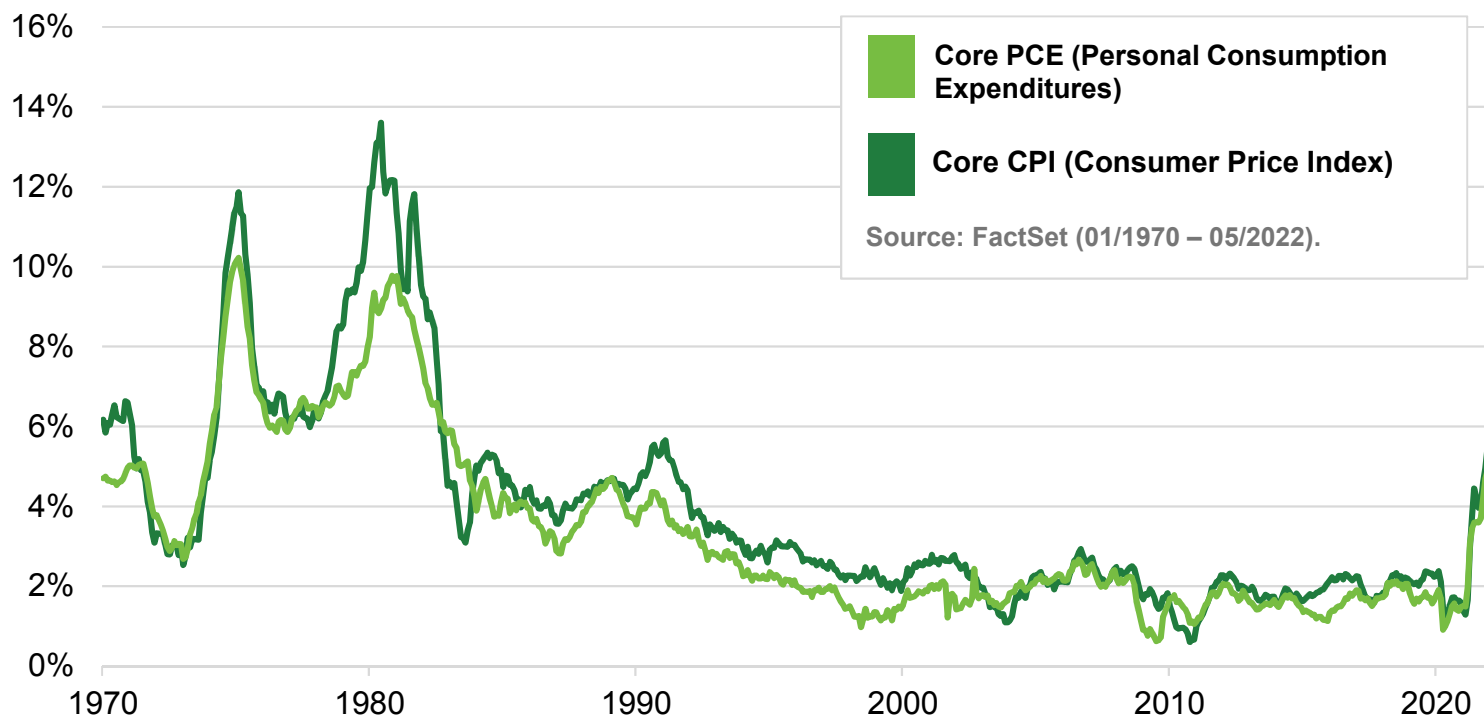

- The Federal Reserve sharply raised interest rates during the quarter, and has signaled their intention to remain aggressive in the quarters ahead as they respond to what is rapidly becoming a late-cycle economy within the US
- Many global central banks, not just the Federal Reserve, continue to tighten policy by raising interest rates and ending/reversing quantitative easing programs, all with the goal of corraling rising inflation

Unrelenting Inflation Pressure

Historical Context for Sharp Turn Higher in US Inflation



- The inflation surge has been stronger than policymakers anticipated, now sparking a sharp response
- Beyond just monetary policy, most government fiscal policies are shifting from tailwinds to neutral—or even headwinds—as governments pull back on emergency stimulus measures and watch out for inflation (with the exception of China)
- The downturn in commodity prices and rising inventories should help to ease inflation from here, but pressure from areas such as housing and the labor market remain, raising the question of how much of today's inflation is transitory vs structural

Expectations Remain Elevated

- The drop in equity prices have brought down equity market valuations from what were very frothy levels, and while valuations are improved, those measures are all still based on earnings expectations that have yet to adjust lower
- Given our economic outlook ahead, we believe it remains too early for investors to significantly increase risk

- As interest rates rise, it results in negative performance for existing bondholders, challenging fixed income returns
- The ongoing rate transition process is painful in the short-term; however, the increase in yields is beginning to create better opportunities for long-term focused, fixed income investors

Current Equity Positioning

Given our cautious economic outlook and the still fairly elevated state of valuations across asset classes, we believe a relatively defensive stance in portfolios remains appropriate and return expectations should be moderate going forward.

We will remain flexible and opportunistic, focusing on the tradeoff between risk and reward as the domestic economy moves into later stages of its economic cycle.

Given this economic and market backdrop, we've incrementally reduced equity exposure with particular focus on cyclical companies that may suffer more acutely in an economic slowdown.

Although our outlook is cautious, we are continuing to find opportunities:

- Our teams believe in the long-term prospects of several growth-oriented industries (e.g., cloud computing, gaming, payment processing, and digital advertising)
- We continue to see value in a few economically-sensitive areas (e.g., logistics networks and railroads), as well as in what we believe are best-in-class companies in a variety of industries (e.g., biotechnology, pharmaceuticals, and consumer staples)
- We recently added several global defense companies given the deteriorating macro environment. We are seeing continued spending commitments within the global defense sector, which we think will provide support to earnings growth

Current Fixed Income Positioning

Though yields have broadly increased, which generally leads to higher future returns, fixed income investors can generally expect a challenging environment going forward due to a combination of tighter monetary policy, high inflation, a stronger U.S. dollar, overall tighter financial conditions, and weakening economic growth.

It is in these types of environments that we believe flexibility and risk management are key to helping investors achieve their objectives.

During the quarter:

- We increased our allocation to agency mortgage-backed securities as valuations notably improved; however, we continue to hold an underweight to the sector
- We began to upgrade the credit quality of our corporate bond holdings
- We increased portfolios' duration (i.e., interest rate sensitivity) as rates rose and economic conditions further deteriorated

For taxable clients:

- We increased exposure to municipal bonds as their valuations improved and they became materially more attractive relative to taxable alternatives due to an overall increase in yields and municipal/Treasury yield ratios

OBJECTIVE SUMMARY

Long-Term Growth Objective

To provide long-term growth, for the purpose of meeting future needs. A secondary objective is to preserve capital and dampen year-to-year volatility.

CURRENT POSITIONING - STRATEGY OVERVIEW

The equity and fixed income markets posted one of their worst first half periods in decades with returns negative across the board. Inflation concerns, tightening monetary policy, the ongoing war in Ukraine, global supply constraints, and a slowing economic backdrop weighed on global markets. There was little return differentiation from a U.S. market capitalization (i.e., larger versus small) perspective. From a style perspective, value stocks (although posting negative returns) generally outperformed growth stocks. Relatedly, typical “value sectors” such as Consumer Staples, Utilities, and Energy relatively outperformed more growth-oriented sectors like Consumer Discretionary, Communication Services, and Information Technology. The broad international markets held up slightly better than the U.S., with the Emerging Markets providing marginal outperformance backed by positive returns from China. From a fixed income perspective, rising interest rates and widening credit spreads led to negative returns, including high yield for the second quarter in a row.

This was not an ideal start to the year, but our investment team has been monitoring and analyzing these market influences for some time and planning accordingly. During the quarter we slightly reduced our overall equity exposure, which was already below our midpoint weight, as the U.S. and other major economies in the world have moved into a late-cycle economic environment, with the odds of a recession rising materially. This view is in large part due to the need for central banks to act aggressively to tame inflation, although tight labor market conditions and strong consumer balance sheets are reasons for optimism. We will be closely monitoring conditions from all perspectives and seek investment opportunities that meet our disciplines. For example, BAE Systems, Northrop Grumman, and L3Harris were added to the portfolio this quarter. We view these companies as strong, defensive holdings and upgrades for the portfolio given the deteriorating macro environment. We are also seeing continued spending commitments within the global defense sector, which we think will provide support to earnings growth. In contrast, we exited our positions in American Tower Corporation and Align Technology as they are likely to experience more volatility in this later cycle environment. We also liquidated our entire position in W.R. Berkley (WRB), a property and casualty (P&C) insurer, as we think industry conditions have peaked and the stock was trading near record valuation.

Within fixed income, we took the opportunity to increase duration during the quarter as Treasury yields continued to rise. From a valuation perspective, real yields had been approaching previous cycles peaks and inflation expectations remained near highs given the current economic backdrop. While we believe inflation may be structurally higher than previous cycles, if nominal growth decelerates and worsens from here, we think inflation expectations are likely to come down and support lower nominal Treasury yields. From an economic conditions perspective, recession odds have increased, which has historically led to higher returns for longer duration, high quality securities like Treasuries. Additionally, we increased exposure to municipal bonds within taxable accounts as their valuation and attractiveness relative to taxable alternatives has improved materially due to an overall increase in yields and municipal/Treasury ratios.

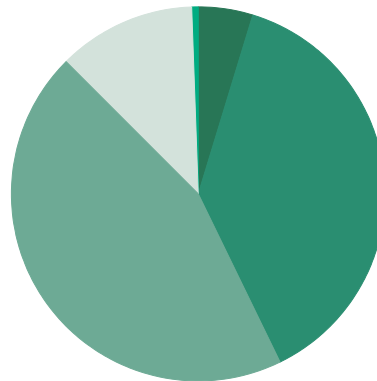

DESCRIPTION OF TERMS & METHODOLOGY

Agency Bond: A bond issued by a government agency. These bonds are not fully guaranteed in the same way as U.S. Treasury and municipal bonds.

Annualized Return: Returns for periods longer than one year are expressed as "annualized returns," equivalent to the compounded rate of return. This is the annual increase in value of an investment, including compounding of interest and dividends; as well as price appreciation that is expressed as a percentage of the starting price.

Bond Rating: A grade given to bonds that indicates their credit quality. Private independent rating services such as Standard & Poor's, Moody's and Fitch provide these evaluations of a bond issuer's financial strength, or its ability to pay a bond's principal and interest in a timely fashion. Bond ratings may be expressed as letters ranging from 'AAA', which is the highest investment grade, to 'C' ("Junk"), which is the lowest grade. Different rating services use the same letter grades, but use various combinations of upper and lower case letters and numbers to differentiate themselves.

AAA and AA: High credit-quality investment grade

A and BBB: Medium credit-quality investment grade

BB, B, CCC, CC, C: Low credit-quality (below investment grade)

Convexity: A measure of the rate of change in the relationship between bond prices and bond yields that demonstrates how the duration of a bond changes as the interest rate changes. Convexity is used as a risk-management tool, and helps to measure and manage the amount of market risk to which a portfolio of bonds is exposed.

Effective Duration: The average time it takes to collect a bond's interest and principal repayment. It is a measure of the sensitivity of the price (the value of principal) of a fixed-income investment to a change in interest rates. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Duration is expressed as a number of years.

Emerging Markets: Emerging market countries are defined utilizing the MSCI Emerging Markets IndexSM.

Estimated Annual Income: Based upon the assets held as of the end-date of the review, an estimate of income from dividends and interest which may be received over the next twelve months. This estimate should be used for general reference purposes only, since it assumes a static portfolio (no purchases, sales or contributions or withdrawals) and utilizes independent company projections of dividend activity which are subject to change.

General Obligation Bond (G.O.): A municipal bond backed by the credit and "taxing power" of the issuing jurisdiction rather than the revenue from a given project.

Key Strategies: The firm's equity approach contains elements of value and growth investing by focusing on business and valuation fundamentals. This approach allows portfolios to move fluidly among sectors and styles, according to which areas offer the greatest opportunity under prevailing conditions.

Strategic Profile: Uncovers companies whose sustainable competitive advantages give them a favorable earnings outlook relative to valuation

Hurdle Rate: Identifies survivors in cyclical industries that are currently depressed

Bankable Deal: Acknowledges under-valued assets with catalysts to unlock them

Maturity Classifications: Maturity is the length of time until the principal amount of the bond must be repaid. Fixed income securities may be classified by a maturity range. Short-Term Fixed Income represents securities with maturities less than three years. Intermediate-Term Fixed Income represents securities with maturities greater than three years, but less than ten years. Long-Term Fixed Income represents securities with maturities greater than ten years.

Market Capitalization: The market value of a company's outstanding shares. This figure is found by taking the stock price and multiplying it by the total number of shares outstanding. Small capitalization stocks have a market capitalization less than \$5.0 billion. Mid capitalization stocks have a market capitalization of greater than \$5.0 to less than \$20 billion. Large capitalization stocks have a market capitalization of greater than \$20 billion.

DESCRIPTION OF TERMS & METHODOLOGY - CONTINUED

Market Cycle - A period of history encompassing a full range of stock market conditions such as one market peak to the next, or one market bottom (often called a trough) to the next. By showing both positive and negative periods, a market cycle provides a representative time frame for measuring investment performance.

Net Asset Value (NAV) The total value of the assets, including stocks, bonds, and/or other securities, owned by a mutual fund, less all liabilities, divided by the number of outstanding shares. This value does not include any sales charges, such as a load or 12b-1 fee. The NAV is calculated once each day after the close of the market.

Par Value: Face value of a bond.

Preferred Stocks: A class of ownership in a corporation that has a higher claim on the assets and earnings than common stock. Preferred stock generally has a dividend that must be paid out before dividends to common stockholders and the shares usually do not have voting rights. The precise details as to the structure of preferred stock is specific to each corporation. Preferred Stock will be classified as fixed income within the report.

Pre-Refunded Bond (Pre-Refund): A type of bond issued to fund another callable bond, where the issuer actually decides to exercise its right to buy its bonds back before the scheduled maturity date. The proceeds from the issue of the lower yield and/or longer maturing pre-refunding bond will usually be invested in Treasury bills (T-bills) until the scheduled call date of the original bond issue occurs.

Revenue Bond: A municipal bond supported by the revenue from a specific project, such as a toll bridge, highway, or local stadium.

Standard Deviation: A gauge of risk that measures total volatility, or the spread of the difference of returns from their average. The more a portfolio's returns vary from the average, the higher the standard deviation.

Time-Weighted Return: The investment performance of a unit of assets held continuously for the entire time period measured. This rate provides an effective standard for comparing the performance of different portfolios, in which cash flow could vary considerably. The

money manager usually cannot control the timing or the amount of contributions to or withdrawals from a portfolio. Because the time-weighted rate reduces the impact of money flows, it is an appropriate means of appraising the portfolio manager's ability to make the assets of the portfolio perform.

US Treasury (Treasury): A marketable, fixed-interest U.S. government debt security.

Turnover Ratio: The turnover ratio measures the percentage of holdings that have been "turned over", or replaced with other holdings during the reflected time period. The lesser of the cost of purchases or proceeds from sales is divided by the average market value for the period and annualized if appropriate for the given period.

Yield to Maturity: The yield earned on a bond from the time it is acquired until the maturity date. The calculation of YTM takes into account the current market price, par value, coupon interest rate and time to maturity.
